S. No.	Pending HR Issues	Remarks
1.	Anomaly in Pay Fixation of Executives recruited in E1A scale [i.e. 22820 issue].	Direct JTOs 2007 & 2008, DR JAOs of 2010 batches recruited in E1A scale are facing this pay anomaly since their appointment.
2.	Promotion orders of Direct Executives from JTO (T) to SDE (T) in SCF quota and LDCE pending up to current VY.	Promotion orders of the Direct Executives in SCF Quota are pending despite all preparation & basic work completed in January'2019. LDCE exams are pending from VY 2011-12 up to current VY.
3.	a. Settlement of all pending rule-8 transfers. b. Lenient interpretation of Rule-8 of transfer policy for the <i>Suo Motto</i> absorption of JTOs in the Circle of deputation under Rule-8 to save cost to our Company.	Executives in JTO cadre are working on deputation in various Circles since years in the interest of BSNL. Therefore they may be absorbed as when & where basis under Rule -8.
