

Respected Madam;

Your good self is well aware that the post 2007 BSNL Direct Recruited Executive (DRE) are the worst sufferer in the Company in all respect. They are being discriminated regularly on the Pay and Promotion front. On the following HR issues, pending for the years together, the DRE recruited after 01.01.2007 are the only sufferer and BSNL Management has still not settled these issues despite several repeated representations and reminders from this association.

- 1. Non-Settlement of the Pay loss issue of the post 2007 pre revised E1A recruited Executives:** Initial basic of Rs. 22820/ in line with other sets of employee.
- 2. Unwarranted delay in issuing promotion order from JTO (T) to SDE (T):** Promotion order from JTO (T) to SDE (T), for which all the official formalities completed, must be issued immediately.
- 3. Non settlement of the Standard Pay Scale for the E1A/E2A Executives:** E2/E3 in place of E1A/E2A as per the DPE/2nd PRC guidelines.


