Greetings!!

Kindly take note of the letters and gentle reminders as under reference written on subject matter to your good self and worthy Director (HR), BSNL Board wherein it was reminded that in the DPC process of JTO to SDE as under reference 2 and 3, around 100 Executives from 2008 batch were left for want of vacancy as per Pers. Section of BSNL CO. However later through an RTI by aggrieved executive, it came to in public that there was sufficient vacancies to accommodate these Executives in the above promotion orders dated 30.12.2021.

The same was pleaded before PGM (Pers) dated 05.01.2022 in BSNL Corporate Office and later through letters and reminders appraised to your high Office. However the DPC of these Executives is still pending for final settlement. Any further delay in this DPC process of left out JTOs of 2008 batch will further create intra batch seniority issues and attract unwanted litigation. These left out Executives are getting demotivated day by day as after 12 years in Executive cadre in BSNL, they have not received a single promotion. Recent past 1891 number of SDEs got promoted to AGM cadre, therefore vacancy in SDE cadre is not at all a problem for DPC of these left out Executives of 2008 batch.

In the light of above, your good self is requested to initiate the process for the DPC of left out JTOs of 2008 batch as sufficient vacancies are there in SDE cadre. We are hopeful that your good self will do justice in the interest of Executive fraternity and our beloved Organization please.
